- The financial results for all periods have been prepared in accordance with Indian Accounting Standards (Ind AS) notified under section 133 of the Companies Act, 2013, read together with the Companies (Indian Accounting Standards) Rule, 2015, as amended from time to time and other recognized accounting practices and policies to the extent applicable.
- The Company is engaged in the trading of iron and steel and related services. During the reporting period, the Company does not meet the eligibility criteria prescribed under Indian Accounting Standard (Ind AS) 108 - "Operating Segments". Accordingly, the disclosure requirements under Ind AS 108 are not applicable, and hence, segment information has not been presented.
- The Company has neither Subsidiary nor Associates and Joint Venture, hence the Indian Accounting Standard (Ind AS) - 110, "Consolidated Financial Statements" is not applicable to the Company.
- On November 21, 2025, the Government of India notified four Labour Codes - namely the Code on Wages, 2019, the Industrial Relations Code, 2020, the Code on Social Security, 2020, and the Occupational Safety, Health and Working Conditions Code, 2020 - consolidating 29 existing labour laws. The Ministry of Labour and Employment has also issued draft Central Rules and FAQs to facilitate assessment of the financial impact arising from the regulatory changes. The Company has assessed the impact on its financial results and has appropriately considered the same; however, the impact is not material to the Company.
- During the reporting period, the Company invested an amount of ₹ 158.64 Lakhs in a partnership firm namely "SILVERSTONE INFRAVENTURES" by way of fixed capital and current capital contributions. The partnership firm is primarily engaged in layout development activities. Further, the Company may make additional capital contributions, as and when required, towards meeting the routine operational and business requirements of the partnership firm.
- The figure for the quarter ended March 31, 2026, and March 31, 2025, are the balancing figures between the audited figures in respect of full financial year and the published unaudited year-to-date figures up to the third quarter of the relevant financial year.
